McAllen ISD Board Meeting— February 11, 2013

1:30p.m.-4:50 p.m.

This Board meeting dealt with interviews for the hiring of a law firm to be general counsel for the district. There were six (6) firms interviewed. Each had 15 minutes with 10 minutes to answer questions.

The Board vote to negotiate with Atlas, Hall, and Rodriguez. Atlas has 30 attorneys and have been lead counsel for MISD for 40+ years. If negotiations fail with Atlas, Hall, and Rodriguez the next law firm to negotiate with is Walsh, Anderson, Gallegos, Green, and Trevino.

If you plan on applying at a charter school or IDEA, consider the following:

These schools teacher employees are at will: That means you have no rights and can be let go with two (2) weeks notice.

We have now had more than 50+ McAllen AFT members go to work at IDEA. All have left after a year or two at the most.

You are required to fund raise and are expected to work on Saturday and Sunday.

If you get crosswise with a parent, the parent wins and you are gone.

The work day is 7:15 a.m. to 5:30 p.m. and perhaps on into the evening.

You get a cell phone and a lap top. You must answer parent calls until 9 p.m. Reports for school are due by 9 p.m. each night.
