Regular School Board Meeting, November 12, 2012

Farias and Caporusso were absent.

The new Assistant Principal for the Regional School for the Deaf is Lisa Lara. Approved 5-0.

Here is a summary of the main points of the meeting:

IPADS AND COST

A presentation was made by Ms. Arcaute, Assistant Superintendent of Instructional Services, regarding the iPad initiative. The cost of this iniative is \$10,203,545.68 per year for the next three years. The first payment is due on December 12, 2012. Most students will have their iPad by December, 2012.

SCHOOL IMPROVE-MENT PLANS

FINANCIAL

OUR LAW CASE

McAllen ISD has spent \$29,150.55 with the Law Firm of O'Hanlon, McCollom & Demerath (of Austin) to avoid paying teachers, librarians, counselors, nurses, and speech path. since our case started in 2009.

The law firm of Atlas, Hall, & Rodriguez (of McAllen) also has charge fees for our case, but it will not provide information on how much of the fee was purely for the case alone. (This information was obtained through Open Records Request.)

REGULAR School Board Meeting November 26, 2012

The following are some of the highlights of the Board meeting: Ponce announced the changes on the District Web page. It is nice to see the new focus on children, parents, and staff instead of administration.

McAllen (and the other six (6) out of state districts) are in the list of 61 finalists in the Race to the Top Grant. This grant affects all high school and middle school employees. The grant will bring even more work to the employees. We requested in Open Records the folks who voted on the JPCC for the 70% of the employees in high school and middle school. Houston. All but two (2) of these voters are elementary teachers and are not necessarily impacted by this decision. These folks now make your job much harder. You need to ask them why they did this to all of you.

The other districts in Race to the Top that McAllen will be working with if they win are as follows: Vancouver, Washington; Mooresville, North Carolina; Utica, Michigan; Piedmont, Alabama; Meridian, Idaho; Horry County Schools, South Carolina.

The win was announced on the U. S. Department of Education web site on November 26, 2012 under Vancouver, Washington's name. If the District wins, your evaluation will be tied to the scores of your students. Utica, Michigan School District will handle the financial part of the Grant.

Mr. Hitchcock, Executive Director of Facilities, Maintenance, and Operations, gave a brief report of this important part of the District. Custodial and facilities are working well. Maintenance has been neglected. Hitchcock is carefully reviewing maintenance so that things will improve.

Dr. Barrera discussed the agenda item related to marquees at various campuses. Mrs. Erica de la Garza Lopez discussed the possibility of combining in the bid 26 marquees not just 14. Some of the marquees costs would be covered by insurance (March 29, 2012 storm). This item will come back to the Board.
