An approval of request for maximum class size waiver application for 14-15 was approved by the Board.

In addition, during April, May, and 1 week in June the Texas Education Agency hired an outside firm to do a survey (all schools in Texas) of how teachers felt about their school district (survey done as required by the Texas Legislature). Administrators from McAllen ISD also used the same survey which really changes the outcome. The survey has been published, and we are preparing the information for publication next week to all our active members and retirees. Your school district had to score 50% + 5 to have the survey results published--we made the goal. Roughly 30% of our members do not have email or a computer--thus we continue to send things home. I have given input to Texas AFT on how the survey should be revised next time.

We suggest you do not use your IPad to communicate with us. The district has the right to read all email you send out on district equipment. We send you updates several times a week on your PERSONAL EMAIL. We also send out McAllen AFT News and McAllen AFT Eyes on the Board by mail New teacher pay is \$44,000 per year--those starting the "0" year.
